

The Monitoring Committee shall have the following functions:-

- i. Review and monitor the progress of registration through National database of Unorganized Workers (eShram Portal)
- ii. Review and monitor the working of field level individual Common Service Centres (CSCs) and 3-Jan Savidha Kendras district wise and achieving targets under Unorganized Workers (eShram Portal)
- iii. Mobilize target sub-groups of Unorganized Workers such as MGNREGA Workers, Self Help Group Members Under National Rural Livelihood Mission (NRLM)/Domestic Workers, ASHA Workers, Anganwadi Workers, agricultural Labourers, Fishermen & Brick-kiln Workers through respective line departments district wise for enrollment under unorganized Workers (eShram Portal)
- iv. Channelize labour unions/workers' associations/federations/civil society organizations working for welfare of Unorganized Workers and traders (small retailers & shopkeepers) to convince and mobilize their respective members to join the unorganized workers social security scheme
- v. Devise and monitor implementation of State wide awareness programs through discussions, seminars, public meetings, students participation, universities, Colleges, media channels, news items, campaigns, pamphlets, posters, banners, help-desk tables in District Labour offices/ District Industries Centre Offices/Skill development Centres/strategic locations/ other District Offices
- vi. Devise ways to understand & resolve public Grievances brought to the notice of this Committee
- vii. The Committee will meet at least once in three months.


